REGULATION

ON DOING ADDITIONAL CONSULTING ACTIVITIES IN THE EDUCATIONAL COMPLEX OF THE POLICE OF THE RA

GENERAL PROVISIONS

- 1. One of the priorities of the Educational Complex of the Police of the RA (hereinafter referred to as the Educational Complex) is to provide additional consulting to the learners.
- 2. The implementation of additional consulting activities is intended for the establishment of beneficial environment for the learners.
- 3. The implementation of additional consulting activities is intended for the mastery of knowledge, development of professional skills and competencies, and provision of conditions for their involvement in the activities in the Educational Complex.
- 4. To pursue that, learners' assessments and analysis of learning needs and guidance of the support is done.

II. GOALS AND THE SPHERES OF THE ADDITIONAL CONSULTING ACTIVITIES

- 5. The goals of the additional consulting activities are the following:
- 1) Contribution to the development of individuals with wide awareness on the public spheres and with the professional skills to be able to provide public services
 - 2) Contribution to the development of learners' knowledge in line with the modern requirements
 - 3) Contribution to the development of learners' research and analytical skills
- 4) Contribution to the development of individuals with the ability to deal with complex and conflict situations
 - 5) Contribution to the healthy ethical environment among the learners
- 6) Introducing such components in the activities with students by the educational and educational support departments.
 - 6. Additional consulting activities include the following:
 - 1) Additional consulting by the educational departments
 - 2) Additional consulting by the educational support departments
 - 3) Additional consulting by the Department of Scientific Activities
 - 4) Additional consulting by the senior staff of the Educational Complex
 - 5) Additional consulting by the Students' Council.

- 7. The additional consulting by the educational departments is intended for guiding the learner and clarifying the questions on the learning process.
- 8. The additional consulting by the educational support departments is intended for guiding the learner and clarifying the questions in the learner's educational and other needs, in educational processes, and in educative and disciplinary activities.
- 9. The additional consulting by the Department of Scientific Activities is intended for guiding the learner and clarifying the questions in the field of research activities.
- 10. The additional consulting by the senior staff of the Educational Complex is intended for guiding the learner and clarifying the questions raised by them.
- 11. The additional consulting by the Students' Council is intended for guiding the learner and clarifying the questions on realization of student rights and their liabilities.
- 12. A schedule for the meetings with learners is developed by the educational, educational support and scientific activities departments and the report on the provided consulting is compiled 10 working days after the end of the semester and sent to the Education Quality Assurance Department of the Educational Complex.
