**REGULATION**  
**ON THE PROVISION OF NOMINAL SCHOLARSHIPS TO THE LEARNERS OF THE**  
**EDUCATIONAL COMPLEX OF THE POLICE OF THE RA**

**I. GENERAL PROVISIONS**

1. The regulation on the provision of nominal scholarships (hereinafter referred to as scholarships) to the learners of the Educational Complex of the Police of the RA (hereinafter referred to as the regulation) defines the procedure and the conditions on providing scholarships to the bachelor students (free education) of the Academy and College students of the Educational Complex of the Police of the RA.

2. The legal grounds of the current regulation are the 8<sup>th</sup> sub-clause of the clause 3 of the article 17 of “the Law on Higher and Postgraduate Professional Education” of the Republic of Armenia and the decision number 1183 – N on the 27<sup>th</sup> of July 2006 by the Government of the Republic of Armenia.

**II. PROCEDURE AND CONDITIONS OF THE PROVISION OF THE**  
**SCHOLARSHIP**

3. The Educational Complex of the Police of the RA has the right to set out scholarships on its own resources and other resources not prohibited by the legislation of the Republic of Armenia.

4. The name, source, funds of the scholarship and the list of the learners are approved by the Academic Council of the Educational Complex.

5. Scholarship of the Educational Complex of the Police is provided to the bachelor students (free education) of the Academy and College students who have had excellent grades on the exams of the previous academic year, have had public activeness and service discipline, as well as to the students, who had excellent and good grades, as assigned by the Chief of the Police of the RA.

6. The candidacy of the prospective scholarship holders is discussed in the Councils of the Academy and the College and justified conclusions are presented to the Academic-Methodological and Development Department of the Educational Complex.

7. Academic-Methodological and Development Department introduces the list of the prospective scholarship holders to the Academic Council for approval. The Academic Council of the Educational Complex approves it by the open voting with the simple majority of the votes, based on which the Head of the Educational Complex issues a respective decree.

8. The learners who have been awarded a scholarship are given a certificate defined in the annex of the current regulation which is signed by the Chief of the Police of the RA.

9. The provision of the scholarship is revised at the beginning of each semester.

10. During the academic year, the provision of the scholarship to the learner, who has been held liable for breaking rules of discipline, is stopped by the decree of the Head of the Educational Complex.
