10. General Provisions

10.1. Rationale of the education program

In accordance with the mission of the Educational Complex of the Police of the RA, the development of a Master's education program in Law is justified by the need to train graduates who can apply the knowledge gained in the field of law, who will meet the labor market requirements as well as the requirements of the 7th cycle of the National Qualifications Framework, and will be able act in different professional fields of a lawyer in a responsible manner.

In accordance with the education program of the Master in Law, the content and organization of the educational process during the implementation of this course description is regulated by the master's course academic plan, course syllabi, materils ensuring the learning and the discipline of the learners, incorporation

of scientific seminars scientific research activities, scientific-research and scientific-pedagogical internship plans, schedule of the academic processes, as well as methodological materials ensuring the implementation of respective educational technologies.

10.3. Goal of the education program

The program aims to train professional in the governmental, administrative and lawyer's professional fields who will be able to:

- 1) apply the professional knowledge of law in practice, and conduct independent legal studies and research by having theoretical training in the field of law;
- 2) comment on, critically analyze the legal norms, compare them with the norms of the legislations of other countries;
- 3) provide legal advice, legal aid and representation functions.
- 4) carry out in-depth, fundamental and professional activities, including those requiring scientific-research and pedagogical training;
- 5) have a conceptual mindset, can identify issues related to legal regulation in the field of specialization, and trends in the development of law and policy;
- 6) submit substantiated proposals on the resolution of various issues related to legislation or governance;
- 7) provide high quality legal aid and high quality public legal services.

10.4. Principles of the development of the education program

The following principles are the basis for the development of the professional educational program:

- ➤ Coordination. It assumes that the branches and institutes of law should be studied not only individually, but systematically in the frames of a complete program. In such an approach, different courses are combined in one general system, and their interrelations are revealed.
- > Scientificness. The teaching of law is organized by applying and combining legal-comparative, analytical, structural and other methods.
- ➤ Combination of national and universal human values. One of the key goals of the professional education program is to prepare graduates who will be able to live and work in a multicultural, global environment, and combine national and universal human values.
- > Continuation of education. The professional education program is based on a methodological strategy of teaching and learning, that is called to ensure the continuation of education.
- > **Sequence.** The teaching and learning strategy planned in the professional education program is designed to ensure the logical connection and sequence of the courses included in it.

10.5. Mode of studies /full-time, part-time/ and workload in ECTS credits, application requirements

The normative term of mastering the educational program is 2 years with the full-time studies, without a tuition fee, and it is 2.5 years with part-time studies with/without tuition fee.

The workload of the education program is 120 credits with full-time studies and 150 credits with part-time studies.

Applicants for the full-time or part-time education program, without a tuition fee, must have a bachelor degree in law (state diploma), have a position of junior, middle, senior, chief group service for at least one year and be up to 43 years old police officer or serve in the police troops.

Applicants of the part-time education program, with tuition fee, must have a bachelor's degree in law (state diploma).

The admission is carried out according to the respective decision of the RA Government, the decree 8-N of the Chief of the Police of the RA on 18th of May 2012. "On Defining the Procedure for Admission of Applicants to the Educational Institution of the Police of the RA" and the requirements of the "Regulation on student selection and admission at the Education Complex of the Police" approved at the meeting N2 on

Full-time studies

12.1 Structure of the academic plan

The Master's program consists of 2 main components: educational and research, and the work planned by each of them is carried out in the pre-defined academic semesters, with the following proportions of workload of educational and research parts, expressed in credits:

Supplementary courses (0 credits), general education component (6 credits), compulsory professional courses (58 credits), optional courses (8 credits) and research (36 credits).

The educational component of the program consists of the following parts: supplementary courses, general education component, compulsory professional courses, and optional courses. The first two components provide or supplement the general basis of the master's degree, the third components is the content of the master's program, which provides the necessary basis for professional knowledge and skills, and the fourth component is part of the individualized study program.

The research component of the program consists of the following parts: scientific seminar, research activity, scientific-research and scientific-pedagogical internship, and master's thesis.

12.2 Content of the program

Educational component

> Supplementary courses

The supplementary course component is aimed at supplementing the requirements of the previous level of education, if necessary (in case of change of profession or in learning foreign languages). In this component, the availability of 3 supplementary courses is planned in the master program. Supplementary courses are not credited.

General education component (6 credits)

The general courses provide or supplement the general basis of the master's degree. The existence of general courses in the program is aimed at ensuring the proper understanding of the problems of the professional field and the transferability of knowledge and skills of the students. It includes two compulsory courses.

Compulsory professional courses (58 credits)

This is the list of the compulsory courses of the master's program, which provides the acquisition of the knowledge and skills required at the master's educational level in the given specialization. They are developed by taking the current labor market needs into account.

Optional courses (8 credits)

The optional courses are designed to provide the knowledge and skills needed to successfully complete a graduate thesis. The total workload is 8 credits, and the courses are selected jointly with the academic advisor (supervisor) during the 2nd and 3rd semesters. The list of optional courses contains modules with a relatively free content structure and calculated credits, out of which the student has the opportunity to choose three.

Research component (36 credits)

The scientific seminar is a series of regular seminars organized by the body delivering the program (faculty, chair, center, etc.), the schedule of which is defined by the schedule of the given semester of the master's program. During the scientific seminar, the master students are provided with methodological support for conducting scientific research, their skills are being developed to make presentations and presenting reports, conducting scientific debates, and reviewing papers. It has 12 credits workload.

The content of the **scientific research activity** is related to the problems of the student's master's thesis and it is developed jointly with the supervisor. It is organized in the 2^{nd} , 3^{rd} and 4^{th} semesters of study with a total workload of 18 credits.

The scientific-research internship is organized in the 4th semester with an approved program developed jointly with the scientific supervisor. It can be carried out in the frames of scientific topics of the chair or laboratory. It haas 3 credits workload.

The scientific-pedagogical internship is organized in the 4th semester with an approved program developed jointly with the scientific supervisor. It is planned to conduct seminars and practical lessons in the bachelor program, and reviewing the course assignments (if the master student is involved in the educational process of the respective chair and works in the necessary workload). It has 3 credits workload.

Completion of the master's thesis and its defense is the final stage of the master's education program, which is done in the 4^{th} and / or 5^{th} semester. The program is planned for 12 credits for dissertation and defense.

12.4. Content of the program Educational component

Supplementary component

The supplementary courses aimed at meeting the requirements of the previous educational level, if necessary (in case of change of profession or in learning foreign language). Considering the need for free movements of master graduates, and their demand in professional and research labor force in the international market, English is included in the program as a mandatory supplementary course. Due to professional necessity, another foreign language may be included in the student's individual curriculum as a supplementary course by the recommendation of the supervisor. This component is planned for the availability of 1 supplementary course in the master program. Supplementary courses are not credited.

General education component (6 credits)

The general courses provide or supplement the general basis of the master's degree. The existence of general courses in the program is aimed at ensuring the proper understanding of the problems of the professional field and the transferability of knowledge and skills of the students. It includes two compulsory courses.

> Compulsory professional courses (58 credits)

This is the list of the compulsory courses of the master's program, which provides the acquisition of the knowledge and skills required at the master's educational level in the given specialization. They are developed by taking the current labor market needs into account.

Optional courses (8 credits)

The optional courses are designed to provide the knowledge and skills needed to successfully complete a graduate thesis. 13. Assessment methods

The assessment method of applied in the frames of the education program is based on the objectivity

and measurability of learners' knowledge, skills and competencies, with the evidencing, guiding, and incentivizing functions. The following are assessed for the learner: a. knowledge, b. skills and competencies, c. independency and activeness. In order to observe the student's individual professional growth objectively, the assessment procedure considers the primary (initial) condition and the final (outcome) result.

The following are among the methods of course assessment:

1. Theoretical courses:
