PROCEDURE ON THE CITATION NORMS AND ANTIPLAGIARISM

Yerevan-2019

INTRODUCTION

In the Educational Complex of the Police of the RA, creative ideas are encouraged. The efforts of the teaching staff and students to create are encouraged by various means: scientific, financial, technical. In this regard, the protection of copyright and related rights is very important.

Each author must be guided by the most important principles of academic integrity. One of the objects of copyright is literary (literary, artistic, scientific, educational, publicist, etc.) work, and as a result of academic dishonesty, we encounter plagiarism.

There are various explanations for the word "plagiarism", in particular, in part or in full introducing, publishing other's work as one's own, (Modern Armenian Explanatory Dictionary, Yerevan, "Armenia" 1976), partial or complete presentation of other's works in its own name (Contemporary Armenian Language Explanatory Dictionary, Yerevan, "Armenian SSR Academy of Sciences Publishing," 1969), Theory of Armenian Syntax, Yerevan, "Armenian SSR Academy of Sciences Ayi Author, "1967), plagiarism, extracting, appropriation/ in someone else's name as his own writing all or part of the presentation, publication / (explanatory dictionary of synonyms Armenian Language, Yerevan," Yerevan State University ", 2009). Taking into account the importance of this phenomenon, the word "plagiarism" has also been given a legal characteristic, in particular, Article 65, clause 4, of the RA Law on Copyright and Related Rights states that extracting thoughts or syllables from another's work without paraphrasing and without mentioning the source of the acquisition and presenting it as a whole, or representing the work in its entirety as one's own is considered as plagiarism.

I. LEGISLATION REGULATING THE FIELD

- 1. The copyright and related rights legislation consists of the Constitution of the Republic of Armenia, the Civil Code of the Republic of Armenia, the law on Copyright and Related Rights, other laws and legal acts, international treaties of the Republic of Armenia.
- 2. For the purposes of legislative regulation of the law on copyright and related rights the protection of academic honesty and ethics, respect for the work of other authors, exclusion of plagiarism may be mentioned.
- **3.** Chapters 63 and 64 of the RA Civil Code are devoted to the regulation of copyright and related rights that define subjects of copyright, its types, etc.

4. The Law of the RA "On Copyright and Related Rights" provides a more detailed legal reference to the relationships between the authors' rights to the works of literature, science and art.

II. THE MANIFESTATION OF PLAGIARISM

- **5.** In order to exclude plagiarism and maintain academic integrity, it is necessary to apply the citation norms lawfully.
 - **6.** Plagiarism may be manifested in the following cases:
 - 1) the representation of others' work entirely or in part as one's own,
- 2) the original copy of the original text without the reference to the source and the citation in the quotation marks,
- 3) inclusion of thoughts and ideas of another person in his own essay, without reference to the source,
- 4) changing a few words in the original text but maintaining the structure of the idea or developing the original idea without referring to the source,
 - 5) developing their own ideas based on the ideas of others, without referring to the source,
 - 6) attaching different citations and formulations without referring to the source,
- 7) to make a reference to the source you have not read personally but have come across in the work of another author.
- 8) making a list of references that includes sources that you did not read yourself and did not reference them in the work,
- 9) partially or entirely copying your (author's) work that you have already submitted for another course.

III. THE PROTECTION OF COPYRIGHTS AND RELATED RIGHTS

- 7. Copyright protection guarantees are envisaged by various legal acts, in particular, Chapter 5 of the RA Law on Copyright and Related Rights regulates the protection of copyright and related rights.
- **8.** Criminal liability is also provided for violating copyright and related rights, in particular, Article 158 of the RA Criminal Code (violating copyright and related rights).

9. Other types of liability defined by the internal legal acts of the Educational Complex of the Police of the RA can also be used for plagiarism:

IV. FINAL PROVISIONS

- 10. Criteria for citation are defined by the "Procedure on the selection, preparation and defense of diploma work and master thesis", approved by the Scientific Council of the Educational Complex of the Police of the RA on 11.02.2015, meeting number 2, Government Resolution No 327 of 08.08.1997 "On Approval of awarding a scientific degree in the Republic of Armenia".
- 11. The provisions of this procedure extend to the works published in the Educational Complex of the Police of the RA.
